Membership Opportunities

Full Golf Membership: Provides full access to all our clubs facilities, unlimited golf, driving range and cart use, along with all social events and activities. All memberships include a 20% restaurant discount (food only). Privileges are extended to the member, members spouse/partner along with any dependent children living full time at home 25 years of age and younger.

Monthly Dues: \$449

Initiation Fee: \$1500

Dual Country Club Golf Membership: Available to applicants that are current full members of another private country club. Membership provides full access to all our clubs facilities, unlimited golf, driving range and cart use, along with all social events and activities. All memberships include a 20% restaurant discount (food only). Privileges are extended to the member, members spouse/partner along with any dependent children living full time at home 25 years of age and younger.

Monthly Dues: \$299

Initiation Fee: \$1000

Junior Golf Membership: Available to applicants seventeen (17) years of age and younger. Membership provides full access to all our clubs facilities, unlimited golf and range use. Carts are available for use for any members that can present a valid driver's license.

Monthly Dues: \$149

3-Month Trial Golf Membership: Provides full access to all our clubs facilities, unlimited golf, driving range and cart use along with all social events and activities. All memberships include a 20% restaurant discount (food only). Privileges are extended to the member, members spouse/partner along with any dependent children living full time at home 25 years of age and younger.

This membership is a "one time" only membership.

Membership Dues: \$1200 (Due at time of initial sign up)

Corporate Golf Membership: Available for up to 10 designated members. Each designated member must be employed by the said corporation or business. With corporate memberships, there will be a primary member on the account who will be responsible for payment of all monthly membership dues.

Each designated member, on the account, will have their own personal member number for personal charges. Each designated member will need to have their account set up with a credit card on file and have the account set up for auto drafted payments.

Corporate Membership Pricing Structure:

5 designated members - \$1000

Designated members 6 through 10 - \$150 each additional member

Each member is provided with 10 rounds per month including cart, unlimited driving range use and full access to our clubs facilities, along with all social events and activities. All memberships include a 20% restaurant discount (food only). Club privileges are extended to the members spouse/partner along with any dependent children living full time at home 25 years of age and younger.

Social Membership (Club Rio): Includes a 20% restaurant discount (food only), 1 guest pass per month for a round of golf including cart. It also provides full access to all our clubs facilities along with all social events and activities. Privileges are extended to the member, members spouse/partner along with any dependent children living full time at home 25 years of age and younger.

Monthly Dues: \$99

Implementation of Rules of Conduct:

Rio Bravo Country Club has adopted the following rules of conduct for all members and guests. These rules are meant to ensure that all members and guests achieve the maximum enjoyment from the use of all the club's facilities. Violations of these rules will subject the member and/or guest to disciplinary action that will be determined by management.

Golf Course Conduct, Tee Times & Use of Facilities

A. General Conduct and Rules Enforcement

1. Rio Bravo Country Club's Professional Staff and Management has the authority to implement the operation of all aspects of the golf course, including but not limited to starting times, groupings, enforcement of policies and rules of conduct. We expect all members and/or guests to be courteous to all staff, members and guests.
2. Rio Bravo Country Club has adopted the Rules of Golf, Conduct and Etiquette, as formulated by the United States Golf Association. All members and their guests should be familiar with these rules and regulations.
3. Members and their guests are required to follow all Rules and Golf Professional's instructions regarding play and practice

B. Registration & Start of Play

The Rules listed below have been established for all members and their guests to have fair and orderly access to starting times and to ensure an appropriate pace of play

1. General Reservations for tee times are available 14 days in advance.
2. Tee Times are not made for Single Golfers
3. All members and their guests must register with the Golf Shop before playing on the golf course, let the Golf Shop know if you are walking or riding and if you are playing 9 or 18 holes.
4. All play must start at Hole #1 unless otherwise approved by the Golf Shop
5. Foursomes are the preferred groupings at Rio Bravo Country Club
6. Single players on the course have no priority rights. If a single player is on the course, that person must yield their playing privilege and position to groups of two or more.
7. Fivesomes are allowed if they maintain a proper pace of play. If a fivesome cannot maintain proper pace of play the Golf Professional and/or Golf Shop has the authority to break the group up.
8. Any group or groups starting on any hole other than Hole #1 does not have priority when coming around to Hole #1. Scheduled tee times have priority in these instances.

C. Guest Play

1. All guests must either check in themselves or be checked in by a member before play begins. Guests may pay their own fees via credit card, cash or check. Members that want to charge guests to their account may do so but must do so themselves.
2. Members may have up to 3 guests at a time.
3. A guest may only play 1 time per month, regardless of if they play with different members.

D. Golf Carts

1. Golf carts must be operated safely.
2. Golf Carts shall not be driven or parked within 30 feet of any green, tee box, bunkers or hazards except on cart paths.
3. Members and/or Guests that need to be within the 30-foot rule of any green, tee box, bunkers or hazards must inform the Golf Shop and must have a Blue Flag indicating they need to get closer.
4. Golf Carts can only have 2 people and 2 bags on cart at any time.
5. Any person operating a cart must be 16 years of age with a valid driver's license.
6. Golf Carts are not allowed to be left in the parking lot at any time. We ask all members and/or guests to kindly return all golf carts to the cart return area upon completion of your round.
7. Members and/or Guests that violate the rules and regulations for golf carts set forth herein may result in, without limitation, in the discretion of Rio Bravo Country Club, the revocation of golf privileges, the revocation of playing privileges, fines or suspension of membership privileges.

E. Junior Play

1. Junior Golfers (under 18 years of age) must be accompanied by an adult before 1:00pm daily and may not play before 10:00am on weekends and/or holidays unless approved by the Golf Professional.
2. After 1:00pm all junior golfers (ages 14 and above) may play unaccompanied by an adult
3. All junior golfers ages 13 and under must always be accompanied by an adult.

Golf Course Etiquette

A. Golf Course Etiquette

1. Members and/or their guests using the golf course should do their part to make a round at Rio Bravo Country Club an enjoyable experience for all other players. Please adhere to these following guidelines:
 - Please play Ready Golf
 - Anticipate the club or clubs that you may need for your upcoming shot. Get to your golf ball promptly so that you are ready to play when it is your turn. If, for some reason, you are delayed in taking your shot please advise your other players to go ahead and play their shot.
 - The time on and around the green is the main cause for slow play. Study your shot and/or putt while others are playing their shots, so you are ready to play when it is your turn.
 - When approaching the green, drive and park your golf cart on the side of the green that is nearest the next tee. Please do not leave your cart in front of the green where you will have to walk back to get it while the group behind you must wait for you to get out of their way.
 - When you have completed the hole, leave the green promptly and proceed to the next tee. This is where you will record your score on your scorecard. Please do not sit by the green you just finished to record your scores.
 - All members and/or their guests are responsible for understanding our pace of play policy. If your group has fallen behind, please attempt to make sure your group picks up pace. If, for some reason, this is not possible, please kindly let the group behind play through.
 - Always replace your ball marks on the greens

- Always fill your divots with sand
- When entering a bunker, please enter from its lowest entry point nearest your golf ball. After your shot, carefully rake the bunker. Leave the rakes outside the bunkers in an area that is least likely to affect a shot from players behind your group.
- You may play music on the golf course. However, we ask that it is at a volume that will not disturb other players or groups around you. We also ask that you play music that is appropriate and acceptable for all other players and groups around you.
- Although socializing is fun and a great part of the game, please reserve your extended conversations for the 19th Hole.

Proper Attire and Use of Facilities

A. Attire

1. Hats must be worn properly (with brim or bill forward)
2. Blue jeans are not allowed (except for in the clubhouse only)
3. Tee shirts, tank tops, tube tops are not allowed (Tee shirts are allowed in and around clubhouse)
4. Athletic bottoms not tailored for golf are not allowed. This includes gym shorts, tennis shorts, swimming trunks, running shorts, sweatpants etc.
5. Pants worn over shorts or outer shell pants used for protection from weather shall be only those that are designed for golf.
6. Shoes that do not have spikes must have an enclosed heel. Sandals that are designed for golf are allowed.
7. Rio Bravo Country Club is a soft spike facility. Spikeless shoes are required on the golf course, driving range, practice chipping area and practice putting greens. Tennis shoes are also acceptable.
8. Sweatshirts (loose, heavy shirt, typically made of cotton) with hoods are not allowed.
9. Sweatshirts designed for golf (light weight) and sweaters are allowed.
10. **Gentleman:** Gentleman must wear shirts with collars, or mock shirts with a collar of at least 1 ¾ “inches. Shirts must always be tucked in, regardless of the shirt style. Men’s shorts must be no shorter than six (6) inches above the top of the knee. Cargo shorts and pants are not allowed unless they have no flaps, are tailored for golf, and the pockets lay flat and do not balloon away from the body of the shorts.
11. **Ladies:** Women must wear shorts / skirts / skorts that are long enough to not see their bottom area (even if covered by under shorts) at any time standing or bent over. Leggings, unless under a short / skirt / skirt / skirt / skort, are not allowed. Sleeveless shirts or blouses must have a collar or mock collar of at least 1” ; no collar is required if shirt or blouse has sleeves. Tee shirts are allowed if they are plain in design with no more than a small vendor logo apparent on the garment. Racerbacks are only allowed with a collar (no collar = no racerback). Plunging necklines are not allowed.
12. **Juniors:** Juniors will adhere to the same requirements. The only exception is during the junior camps. During these events, all items are approved except for blue jeans.
13. **Spectators:** The attire of non – golfing participants on the golf course or range must be respectful to a private country club’s environment. Spectators may not wear blue jeans or sweatpants.
14. **Outside Tournament Participants:** The Golf Professional Staff will encourage the same dress code for players in outside tournaments.
15. **Outside Tournaments Spectators / Volunteers:** these individuals can wear any items if they are respectful to a private country club’s environment.
16. Bare feet are not permitted anywhere on Rio Bravo Country Club property.
17. Every golfer must have their own set of golf clubs.

B. Cell Phones

1. Cell phones are permitted on the golf course and inside the clubhouse.
2. Cell phones must always be kept on silent mode anywhere on Rio Bravo Country Club property.
3. Talking on your cell phone must only be done in parking lot or patio areas and must not disturb or be near other members and/or their guests.
4. Please refrain from using your cell phone on the golf course unless it is an emergency.

Driving Range Rules

1. The driving range will be open during hours established by the Golf Shop
2. Range balls are for use on the driving range only. Range balls are not allowed to be removed from the range and are not permitted to be used on the golf course or practice putting greens.
3. You must use the driving range from permitted areas only. If mats are used, you must hit from the mats and must not use the grass for drives or any other purpose.
4. Golf carts are not permitted on the driving range tee area.
5. Lessons by unauthorized persons are prohibited.

Membership Initiation, Hold and Cancellation Policies:

1. An initiation fee is due for all new members (excluding social memberships) at initial sign up.
2. All new memberships are based on a 12-month contract from initial sign up. Members have the option of paying the entire 12-month contract up front and receiving a discounted rate (pay for 11 months) or pay in 12 monthly installments.
3. Cancellation of any social or golf membership, for any reason, will not allow that member to return to any level of membership for 12 months.
4. A golf membership can only be put on hold for 1 reason....a valid medical issue. To put a golf membership on hold for a medical issue, the member must present a valid doctors/physicians note to the office to put in members' file. With a medical hold, the member would not have to pay their full golf membership dues but would be responsible to continue their membership at a social membership rate throughout the length of golf membership hold. A medical hold is valid for up to 6 months. If still needing to be on medical hold after 6 months, the member would need to make the decision to resume payment of full golf membership or cancel their golf membership.

Membership Account Policies & Procedures:

1. All membership tiers allow for charging privileges.
2. All members can set up their accounts to autopay their monthly dues on the 5th of each month. Members are also able to pay their monthly dues by cash, check or credit card by seeing the business office or golf shop.
3. Membership accounts past due 30 days will receive an email and/or phone call to try and get the account current.
4. Membership accounts over 60 days past due will be put on suspension. All memberships that are over 60 days will no longer have any membership privileges.
5. Membership privileges will not be reinstated until the membership account becomes current and the member pays a \$150 reinstatement fee.
6. Any membership account with a past due account of over 120 days will effectively have their membership cancelled.

Credit Card Authorization

By signing this application at Rio Bravo Country Club, I hereby authorize Rio Bravo Country Club, to make an inquiry about my financial condition, my family and professional background and specifically authorize Rio Bravo Country Club to make an inquiry into my credit history.

The undersigned does hereby acknowledge, accept and understand that I have truthfully and to the best of my ability answered all application questions. If my application is to be accepted, I agree to adhere to and observe all Rio Bravo Country Club Rules and Regulations in present form or as may be amended.

I also agree to always keep a current credit card on file with Rio Bravo Country Club. Should my account become delinquent, I agree that Rio Bravo Country Club has the right to bill all outstanding charges to said credit card. Credit cards can be set up for automatic payment, but it is not mandatory.
